Detailed Narrative:

Today's visit to this workplace by the Ministry of Labour (MOL) was to gather information following an occurrence. This inspector was accompanied by David Winter, MOL Hygiene Consultant.

The following items were observed/discussed:

The background of the occurrence was discussed.

Two Type 3 abatement projects were conducted between November 23, 2016 and were completed around January 6, 2017.

A third-party consultant was retained to monitor the abatement projects. A copy of the consultant's daily inspection report and air sampling reports have been requested.

An additional third party consultant was retained to review the areas of concern. Copies of air sampling and bulk/air sampling reports have been requested. Air sampling results are reported by OHS to be posted on the portal.

The workplace parties advised that occupants of the building are notified of the construction projects via list serve. Meetings were held in November with occupants. A copy of this notification has been requested.

The Asbestos Management Program is available on the U of T website.

Workparties advised that the mechanical shaft of concern has been sealed. The shaft was observed to be sealed in room 4334 and 6334. The mechanical shaft doors had not been sealed in room 5334 at the time of this visit. Workparties indicated that they would be sealed.
